**Submitted images must be 300 dpi, jpeg format** and sent as attachments via email to <[artspot@frontier.com](mailto:artspot@frontier.com)> no later than **Friday, MAY 10, 2019.**

Please enter “**Fiberarts**” in the **subject line** when submitting images online. Please **include** your **contact information – both email and telephone; medium/technique, title and dimensions** of each submitted piece.

**Notification of acceptance** will be made by **Saturday, May 18, 2019, by phone or email.** An **acceptance fee of \$10.00 per artist is payable at the time of delivery;** and will be applied to publicity and reception expenses.

**Exhibited work** must be **original, for sale, framed and wired** (no saw-tooth hangers please); **top-finished with casement and a rod, or otherwise presented for hanging or installation in a manner appropriate for a gallery setting.**

**Accepted artwork should be delivered** no later than **Saturday, June 8;** and **picked up** after the show no later than **Saturday, July 6, 2019,** during gallery hours. **FRI 1 – 6 PM; SAT 10 AM – 4 PM.**

**Artist agrees work will be displayed the duration of the show;** and that **MSAS has permission to use images of his/her work for promotional purposes.**

**Artist agrees to be present during the OPENING RECEPTION, 5 – 9 PM, FRIDAY, JUNE 14, 2019.**

**MSAS will receive 35% commission on all sales.** Please **price your work accordingly.** **Post-show sales,** generated through this exhibit, are appropriately **subject to the 35% gallery commission,** since the Art Spot survives on commissions. Please send a check to **MSAS,** at our address as given above. **Art Spot commission checks will be issued on the 15<sup>th</sup> of the month following the month of the sale.**
